Eligible exhibitors can also claim reimbursement of 50% total freight amount with an upper ceiling of ₹50,000/- per participant towards shipment of exhibits. The amount of reimbursement shall be subject to the approval and quantum of funds approved by the Ministry for the said event. The participation charges of the Council are inclusive of space rent, built-up booth, carpet, spotlights, furniture, standard display aids and electricity charges. The Council/show organizer reserves the right to selection of participants.

The participation guidelines of Messe Frankfurt GmbH for Ambiente shall be applicable. Booth allocation will be based on product profile of the exhibitors and approval by the show organiser.

Interested members are requested to submit their duly filled application form in the prescribed format (enclosed herewith) along with an advance amount of Rs. 3,75,000/- by way of DD/RTGS in favour of the Export Promotion Council for Handicrafts payable at New Delhi latest by **20th September 2024 (Friday)**. The applicants will be informed to deposit the balance participation charges by demand draft/RTGS order only after selection by the Council. In case of withdrawal of participation after the selection by the Council, the application money will be forfeited. 	 Participation application should be in prescribed format and be submitted within the prescribed date for booking of space. Submission of application to EPCH does not automatically confer a right for allotment of space. Approval of application for
	space will rest with EPCH.

With regard to participation in fairs / exhibitions abroad, Ministry of Commerce & Industry, Govt. of India has recently made certain amendments in the existing MAI guidelines for the beneficiary under MAI scheme vide dt. 26.6.2023. Some excerpts of the scheme related to exporter's participation in international fairs are provided as follows:

MAI Guidelines for space booking & participation:

- A member can avail grant in aid for maximum of three participations in a particular trade fairs / exhibition.
- Members who have availed MAI assistance three times (including past cases) for particular fairs / exhibitions thereafter member have to participate in that fair on their own cost. Further, MAI funding support was only be provided to a member for a maximum two MAI events in a year.
- In the case of exporters belonging to SC/ST/Women and the exporters having f.o.b. value of exports of or less than Rs.50 crore in a year, 5 participations in a particular event is allowed. In the case of exporters belonging to SC/ST/Women and the exporters having f.o.b. value of exports of or less than Rs.50 crore in the preceding year, 5 participations in a year is allowed, provided each one of these is in different market (e.g. Africa, LAC, WANA, ASEAN, etc).
- The above guidelines as such would be adhered strictly and all exporters / members may please note
 the same, while applying for participation in any fair under MAI scheme for availing grant in aid. However,
 member can participate beyond the prescribed limit of the guidelines on their own expenditure under the
 umbrella of the EPCH.

Airfare Reimbursement Guidelines:

- i. The ceiling of airfare reimbursement to Indian exporters for participation in events abroad and also for hosting foreign buyers in RBSMs in India enhanced by 20%, as indicated below, with effect from FY 2023-24:
- a. ₹1,50,000/- for Africa and American continents; and
- b. ₹ 90,000/- for other markets (such as Europe, WANA, ASEAN, CIS, NEA etc).
 - ii. Reimbursement of airfare to the companies having nil exports/ start-ups/ new exporters may be allowed up to 10% of the total number of participants, subject to the following conditions:
 - a. The amount of airfare reimbursable will be 50% of the economy fare, subject to market-wise ceilings prescribed in the Scheme guidelines.
 - b. The exporter has been active in the domestic market and has at least annual turnover of ₹ 50.00 lakh in the preceding financial year.

(Note: For other exporters also, it will be necessary to have minimum annual export turnover of ₹50 lakh in the Preceding financial year to avail reimbursement of airfare.)

Reimbursement of freight charges of exhibits

- MAI Support provided for shipment of exhibits on 50% funding basis to Micro and Small Enterprises, as defined in the MSME Act, with an upper ceiling of ₹50,000/- per exporter per event.
- Such Support of Freight charges will be available to only such exporters who are eligible for airfare reimbursement under the Scheme, i.e. the exporters having f.o.b. value of exports of less than ₹50 crore in the preceding financial year.
