# Sustainable Manufacturing Practices to Enhance Competitiveness & EU Regulation on Deforestation-free Products (EUDR) -Way Forward

The European Union has introduced a new regulation, the EU Regulation on Deforestation-free Products (EUDR), aimed at addressing the problem of deforestation and degradation associated with cattle, soy, palm oil, cocoa, coffee, rubber, and timber and wood products. EUDR will come into effect on 30th December 2024 and aims to encourage the creation of a "deforestation-free" market in Europe and globally. EPCH already has a robust Indian Timber Legality Assessment & Verification Scheme (VRIKSH), and the Council is now going one step further by incorporating the necessary compliance of geo-location pertaining to deforestation-free/degradation-free land into the standards of its existing scheme VRIKSH, thus providing a viable solution to wooden handicrafts exporters.


